### Terms of Contract:

1. Exhibitors agree to provide a professional display AND A SIGN WITH THEIR BUSINESS NAME ON IT.
2. NO PACKING UP BEFORE THE END OF THE SHOW!
3. Set up days are Thursday, September 23, 2021 (1-8) and Friday, September 24, 2021 (8-8) Set up must be complete before the show opens. *If rain is in the forecast, feel free to call us if you would like to set up your tent early.*
4. All vehicles must be removed from booth areas into designated dealer parking area by 8:30 a.m. on Saturday. Please be respectful of others and **NO VEHICLE IS TO LEAVE PARKING LOT BEFORE 3 PM**, your booth must be packed and ready to load before taking your vehicle out of vendor parking lot. Absolutely no dealer parking in customer parking area.
5. Booth fee (non-refundable) of \$150 and \$75 (covered \$210 and \$115) for each additional space is due with application unless we cancel the show or your application is denied. *Your booth fees pay for advertising the show, so receiving them in a timely fashion is greatly appreciated.*
6. The exhibitor will not sublet any part of his/her booth without permission and approval of the show promoters of the additional vendor, who must also complete an application. There will be a \$75 fee charged for each additional vendor in a booth and the **ADDITIONAL VENDOR MUST BE APPROVED BY THE SHOW PROMOTERS**. There will be a limit on shared booths as we feel it takes away from the quality of the show and we reserve the right to refuse any vendor from sharing a booth.
7. Each booth is allowed one (1) helper – this does not include family members or a vendor who is sharing the booth with you. **ALL** vendors and helpers **MUST** have a name tag, so please fill out the appropriate section of the application in advance.
8. The exhibitor is responsible for his or her own insurance bodily injury, property damage and product coverage. The field will be monitored and secured after set up.
9. Exhibitors must provide their own tents and tables. We have a limited amount of covered 10'x 10' tent spaces, first come, first serve. See Contract for details and call for availability 508-341-6870 (Kris).
10. Applications are due by August 15, 2021 in order to hold your spot. We will provide you with postcards to mail and hand out to your customers as well as advertise in various trade publications. We will do a direct mailing to our mailing and e-mail lists.
